

PRIVACY POLICY

This policy describes how your personal information is collected, used, stored and shared when you visit www.currenttaxi.ca or download/use the Current Taxi app. By installing the Current Taxi app, visiting the website www.currenttaxi.ca or using Current Taxi services, you agree to the terms and conditions of Current Taxi's Privacy Policy.

1. INFORMATION

Personal information collected includes but may not be limited to:

- Name
- Phone number

Optional personal information includes:

- Email address
- Photo
- Payment information (direct credit card payment option)

Information Current Taxi and its third-party partners may collect and process data about you relating to:

- the provision of services or online content in order to deal with your requests and enquiries.
 This includes data provided at the time of subscribing to any services or news Current Taxi offers, downloading data posted on the Site, the Apps, Dispatch Panel and/or Company panel, posting material or requesting further services;
- data in connection with or participation in any promotions or competitions sponsored, promoted
 or offered by us and/or any third party and any data provided to us by way of feedback, profile
 forms or site issues;
- your contacting us, for example by text, email, post or telephone, in which case Current Taxi
 may keep a record of that correspondence in our customer relationship management system
 to respond to your enquiries and improve its services. Thereafter, Current Taxi may use your
 email address and/or phone number to contact you about its services;
- other information from your interaction with the Site, the Apps, Dispatch Panel and/or Company panel, services, content and advertising, including computer and connection information, statistics on page views, traffic to and from the Site, ad data, IP address, standard web log information and the resources that you access, when it is required for Current Taxi's own purposes;

- Current Taxi will not sell, distribute or use any personal information other than for the purpose stated herein this document:
- reasonable safeguards are in place to protect collected information;
- we will also share your personal data with law enforcement agencies or public bodies if we are required by law to do so.

2. VIDEO

- Many of Current Taxi vehicles are outfitted with PTB approved security cameras to protect both the driver and the passenger.
- Current Taxi will not distribute, duplicate, or view video footage unless required to do so by law.
- Current Taxi cannot supply passengers video footage unless required to do so by law.

4. TECHNOLOGIES

When using the website or app, services provided by the website or app, personal information will be collected including information about your device browser and IP address, location data and details of your visit.

We collect Device Information including but not limited to the following:

 Cookies are data files that are placed on your device or computer and often include an anonymous unique identifier. For more information about cookies, and how to disable cookies, visit http://www.allaboutcookies.org.

- Log files track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.
- Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Site.

If you have voluntarily signed up with one of our affiliates as a part of a joint promotion or contest and no longer wish to receive their communications, you must unsubscribe yourself from their email list. Current Taxi retains no ability to control or responsibility for the email contents or frequencies of our affiliates.
